## 1. MEDCO MAC INCREASES:

- Olanzapine 10mg Tabs increased from \$4.2042/tab to \$10.9136/tab effective 10/5/11.
- Dextroamphetamine 10mg Caps increased from \$1.726/cap to \$3.5973/cap effective 10/27/11.
- Clobetasol Oint increased from \$0.67/g to \$2.4327/g effective 11/4/11.
- Metronidazole Lotion increased from \$1.4072/ml to \$2.5761/ml effective 11/5/11.
- Chlorthalidone 25mg Tabs increased from \$0.111/tab to \$0.4105/tab effective 11/27/11.
- Metronidazole Cream 0.75% increased from \$0.884/g to \$2.844/g effective 11/27/11.
- Clobetasol Solution 0.05% increased from \$0.3036/ml to \$0.5760/ml effective 11/29/11.
